The position conducts fieldwork, field research and field surveys and contributes to studies of the distribution, habitat, biology and vulnerability of New Mexico's rare and endangered plant species, including studies to document the presence or absence of endangered plants in the proposed project areas of various federal and state agency activities. The position assists in the discovery, surveillance and/or planned surveys related to invasive plants.
